Greetings,

The S.C. Commission for Minority Affairs' statewide Second Chance Reentry Resource Guide (SCRRG) is designed to enhance the transition process from incarceration to emancipation. In 2019, South Carolina spent approximately \$23,673.00 to house an inmate. In order to facilitate emancipation and to save money, the state frees more than 7,500 inmates per year that have three years or less to serve on their sentences. This saves the state approximately \$177,997,000.00 annually. In 2016, of the more than 9,100 inmates released, approximately 21% returned to prison. The SCRRG seeks to reduce recidivism and increase expungement eligibility for the formerly incarcerated by offering a roadmap to reintegration into society.

This resource guide uses a common sense, evidence-based approach to reducing crime, improving public safety and expanding the workforce. It provides people who were formally incarcerated with a comprehensive toolkit that consolidates reentry services available in the state of South Carolina. The SCRRG will help bar the revolving doors that lead to reincarceration and offers a clear path to lasting freedom.

This resource guide was made in collaboration with South Carolina agencies, including the S.C. Department of Probation, Parole and Pardon Services; S.C. Department of Corrections; and the S.C. Department of Employment and Workforce. It was also made in partnership with civic, faith-based, and community organizations to bridge the gaps between incarceration and emancipation on the road to prosperity.

It is made in the spirit of the words as stated by former President George W. Bush, "America is the land of the second chance - and when the gates of the prison open, the path ahead should lead to a better life."

It is our hope that through this Resource Guide many will find what they need to build a better life for themselves and their family.

EXECUTIVE SUMMARY

When the South Carolina Commission for Minority Affairs was signed into law in 1993, one of the agency's focus area was developing programs to address disproportionate minority incarceration. Today, a full 28 years after the Commission's initial findings, incarceration remains a serious issue in South Carolina. Though racial minorities make up approximately 31.5 % of South Carolina's general population, they comprise 62 % of the state's inmate population. [1] Meaning minority South Carolinians are twice as likely to be incarcerated than their non-racial minority peers.

However, issues around incarceration go beyond race and also cover educational attainment: about half of South Carolina's inmate population does not have a high school diploma or GED. [2] Moreover, about 69% of female inmates have been diagnosed with a mental illness. [3] These statistics mean that inmates will leave correctional facilities with issues that can significantly affect their re-entry into the workforce. South Carolina's struggles with a changing economy and job readiness have been well documented. [4] For those re-entering the workforce with prior convictions, educational deficiencies, or mental illness, the economic prospects can be even more grim. This puts many at risk for recidivism.

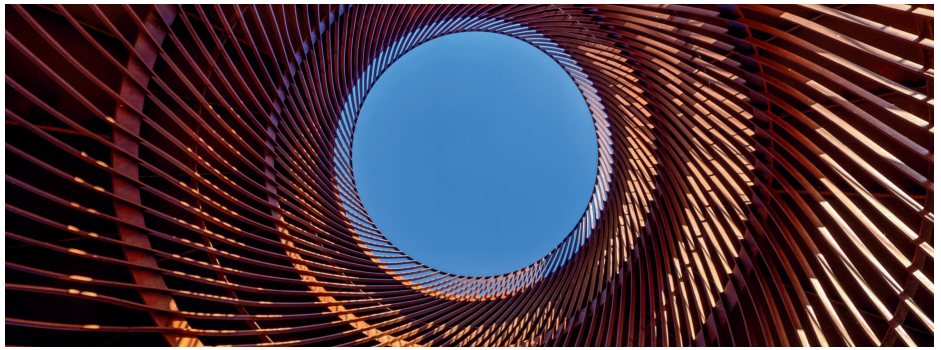
Because of the varying obstacles faced by those re-entering the workforce, the South Carolina Commission for Minority Affairs aims to offer them fresh start. This guide provides a directory of various resources that includes information on housing, vocational rehabilitation, mental health, legal services, substance abuse treatment, and more that will ease the transition from correctional facilities to places of employment.

OBTAINING IDENTIFICATION

It is imperative for an individual to have some form of government-issued identification for employment and other purposes. Many of those leaving incarceration may lack sufficient knowledge of what is necessary to obtain government issued identification, yet, oftentimes, it is as simple as possessing a birth certification and / or social security card.

According to the SC Department of Motor Vehicles, to receive a free state sponsored identification a person must have a current ID that will expire within 12 months. For example, John Doe's ID card expires in February 2021, he is eligible for a free ID.

To receive the free ID, this must also be the person's first ever ID card. For example, Jane Doe has never had an ID card before BUT her current license and photo are still valid. She gets a free ID.

To receive the Free ID, all other credentials MUST be turned in to the South Carolina Department of Motor Vehicles. EX: John Doe had a motorcycle permit and a car license. John Doe will have to turn in both to get a free ID card. If John Doe had an ID card that is still good until 2024, then it will cost \$10 to get a duplicate. If Jane Doe had a permit that is still good until 2021, then it will cost \$2.50 to get a duplicate.

Once credentials have been expired for more than 9 months, the applicant can only obtain a new identification with original documentation. For example, John Doe's credential expired in 2001, thus he must submit all original paperwork to receive new identification.

DOCUMENTS NEEDED TO OBTAIN AN ID CARD

Social Security Cards: To obtain a social security card, please call 1-800-772-1213.

Birth Certificates: You must submit a valid government ID, pay a processing fee and submit an application to apply for a copy of a birth certificate. To obtain a copy of your birth certificate, contact the South Carolina Department of Health and Environmental Control. There are several ways to request a South Carolina birth certificate:

Entering the Community After Incarceration — How We Can Help

[SocialSecurity.gov](https://www.SocialSecurity.gov) |   

Social Security and/or Supplemental Security Income (SSI) benefits are suspended when people are confined to jail or prison.

- For Social Security beneficiaries, benefits remain suspended until the inmate is released.
- For SSI beneficiaries, benefits are terminated when the person is incarcerated for a year or more.

People need funds to cover living expenses when they're released from prison. To help them make a successful transition back into the community, benefits need to be started as soon as possible.

How soon can benefits be started after release?

The amount of time it takes to start benefits depends on the person's situation:

- If Social Security benefits were only suspended, Social Security can usually restart them without much delay;
- If benefits were terminated, benefits can take a few months to resume; and
- If the inmate wasn't previously entitled or eligible for benefits, and is alleging a disability, or SSI benefits were terminated a new application and disability determination are required. In this situation, a decision about the

person's disability could take from three to five months.

Is there a way to expedite benefit payments?

By following a special procedure before release, we can pay benefits much sooner. We refer to this as the prerelease procedure.

How does the prerelease procedure work?

When an institution has a prerelease agreement with Social Security, we can:

- Begin processing an inmate's application up to several months before the inmate's scheduled release date;
- Make a prospective determination of potential eligibility and payment amount based on the inmate's expected circumstances after release; and
- Start paying benefits shortly after the inmate is released from the institution.

When notified by the institution, Social Security will follow this procedure if the inmate is likely to be eligible for benefits within 30 days of his or her scheduled release date.

How can institutions establish a prerelease agreement?

Either the local Social Security office or the institution may initiate a discussion about setting up a prerelease agreement.

The prerelease agreement:

- May be an informal verbal agreement; or
- May be a written agreement signed by both parties.

What are the responsibilities of each party?

Social Security's responsibilities

In a typical prerelease agreement, the Social Security office will:

- Provide guidelines about what evidence is needed;
- Provide a contact person to assist the institution and the inmate in applying the prerelease procedures;
- Process claims and reinstatements in a timely manner; and
- Notify the institution promptly when Social Security has made a decision about the inmate's eligibility for benefits.

Institution's responsibilities

The institution will agree to:

- Notify Social Security of people scheduled for release in the

near future who may be eligible for benefits;

- Provide available current medical evidence or nonmedical information for the inmate including a statement about the inmate's ability to handle funds;
- Provide Social Security with the anticipated release date; and
- Notify Social Security as soon as the inmate is released or changes that delay the release date.

What are the advantages of a prerelease agreement?

A prerelease agreement:

- Allows both parties to streamline the process for starting/restarting benefits promptly after an inmate is released; and
- Facilitates the inmate's return to the community by providing him/her with an adequate source of income.

Federal Bonding

Providing the confidence for second chances

The Federal Bonding Program provides fidelity bonds to employers who are reluctant to hire jobseekers considered “at-risk” or hard-to-place due to things such as judicial involvement, substance abuse recovery, poor credit, lack of work history or dishonorable discharge. A fidelity bond can also be provided to avert a layoff or secure a promotion.

Bonds are made available through the S.C. Department of Employment and Workforce (DEW).

Quick Facts:

- Enrollment in the SC Works system is required for an individual to be bonded.

- Federal Bonding provides employers protection against loss of money or property due to employee dishonesty.
- Bonds are issued for the first **six months** of employment.
- Bonds are typically issued for **\$5,000** of fidelity insurance coverage.
- There is no cost to the bond-eligible employee or the employing business.
- Federal Bonds are processed by the DEW State Federal Bonding Coordinator.
- Bonds automatically terminate after **six months**.

LET ME VOTE

IN SOUTH CAROLINA, YOU HAVE THE RIGHT TO VOTE
EVEN IF YOU HAVE A CRIMINAL RECORD

If you were convicted of a felony:

- You can vote if you have finished your sentence.
- You cannot vote if you are incarcerated.
- You cannot vote if you are on probation or parole.

If you were convicted of a misdemeanor:

- You can vote once you're released from jail.
- You cannot vote while you're in jail.

If you were convicted of any crime involving a violation of an election law (including a misdemeanor):

- You can vote if you have finished your sentence.
- You cannot vote if you are incarcerated.
- You cannot vote if you are on probation or parole.

If you are in jail awaiting trial or for child support contempt:

- You can vote by absentee ballot.

Remember!

Once you become eligible, you must register or re-register to vote.

- Find your polling place at www.scvotes.org.
- Bring your signed voter registration card to the polls. You may also use your SC driver's license or SC DMV-issued identification card. (*ID requirements may change before the November election.*)

OBTAINING A STATE LIBRARY CARD

South Carolina residents age 18 and older may receive a free South Carolina State Library card to access print materials and online resources. Resources include eBooks, educational resources, digitized newspapers, and more.

The South Carolina State Library provides eCards during the COVID-19 pandemic. Qualified applicants will be emailed an eCard number and temporary PIN after the application is processed. eCard requests will be processed from 9 a.m. to 5 p.m. Monday-Friday. Most requests will be filled in about 24 hours. Those requests received during weekends may take longer. eCard users will receive a physical library card in the mail.

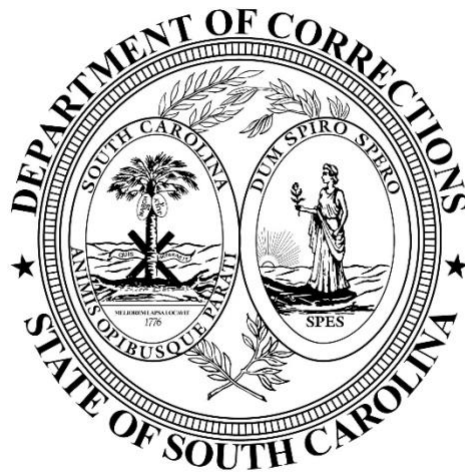
